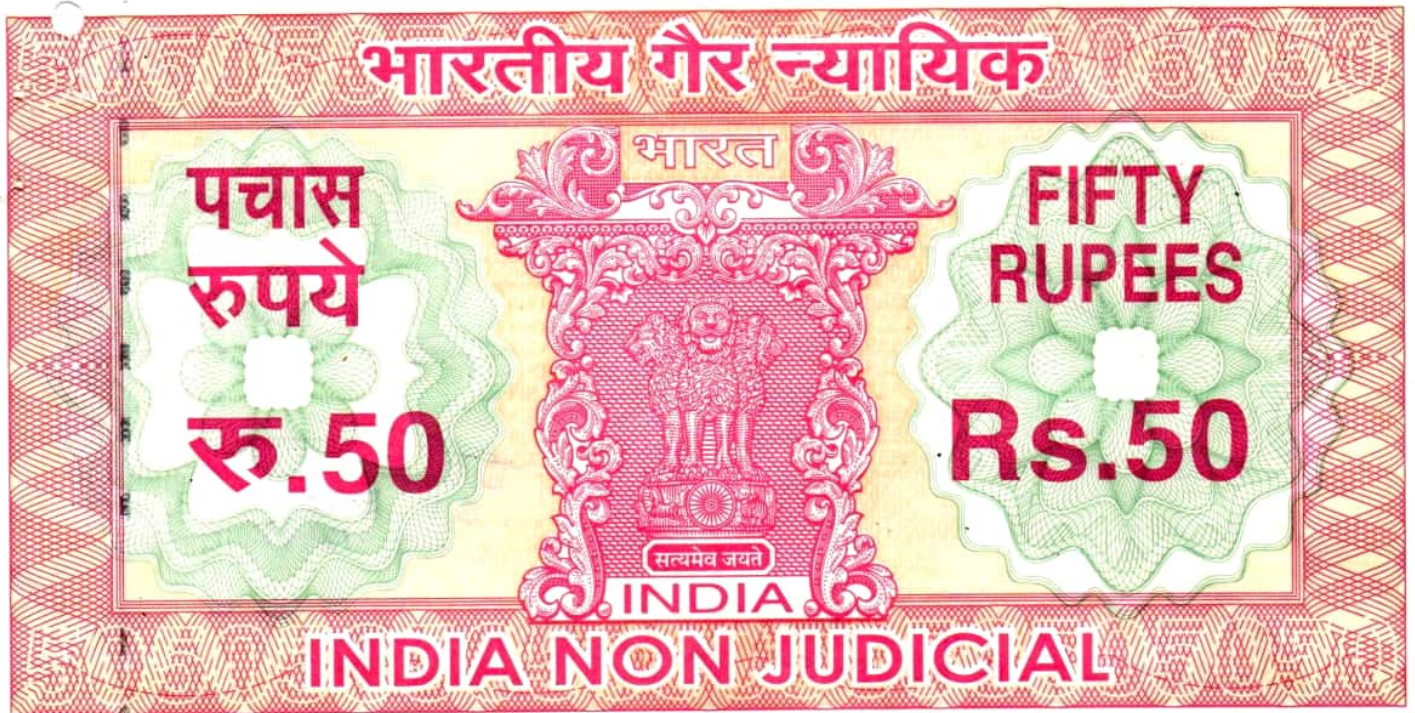

1. That, in order to effectuate the said desires of the settler, the settler does hereby transfer, assign and make over to the trustees the said sum of Rs.2,000.00(Rupees Two Thousand) only (the receipt whereof the Trustees do hereby admit and acknowledge) to have and to hold the said sum and the accumulation thereof and the accretions that to including all other sums, shares, securities, and other properties which may be received by the trustees hereafter by way of donation, gift, subscriptions, income, interest, divided or otherwise whatsoever or however accruing that may for the time being form the assets of the said TRUST PROPERTY upon Trust for public and charitable purposes and with subject to the powers, provisions and declarations herein contained or concerning the same).
2. The Trust shall be named as "**GAJANAN EDUCATIONAL TRUST**" hereinafter called the "**Trust**".
3. The Corporate office of the Trust shall be situated now at **Plot No.- 1324/1935, Abid Complex, Near New Bhagaban Tower, Canal Road, Jharpada, Bhubaneswar-06, Dist-Khurda, Odisha**, and / or at such other place or places in India as the Trustees may decide from the time to time.
4. The trustee shall get in and collect the income, interest, dividend and profit of the trust property from time to time and shall there from pay at first instance all costs, charges and expenses of and incidental to the administration and management of the Trust property and shall hold the net balance of the income and the corpus of the Trust property for the objects hereinafter mentioned.
5. The objects for which the Trust is established are relief of the poor, education, medical relief and the advancement of any other object of general public utility, not involving the carrying on of any activity for profit, and for such purposes.

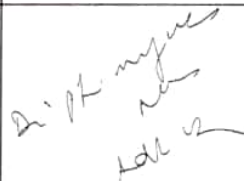

WHEREAS the Settler / Author of the Trust is having a keen desire to promote education based on Engineering, information Technologies, Management Studies, Culture, Advancement of Educational Activities and all other Educational disciplines in all its branches, such as all PG and Degree Programmes (**regular and distance mode**) kinder garden, primary and High School, College, leading upto and teaching diploma, degree, postgraduate and doctorate course in Arts, Science, Commerce, Computer, Engineering, Medical, Pharmacy, Dental, Nursing, Management, Music, Fine Arts, Aeronautic , and to import industrial training in the field of production and process to develop other industrial activities and also such other subject as the Managing Trustee/Chairman of the Trust may deem fit for the benefit of the students of all castes and communities both for India and other countries, and information technology in the State of Odisha and also in other part of the country constituted the Trust on dtd, 05.04.2014 and made over to the Trustees a sum of Rs.1,000/- (Rupees one thousand only) by the Trustees with an intent to part with all the right, title and interest claim therein and vest the same in the Trustees to have and hold the same and the investment of investments for the time being represents the Trust estate together with all addition and accretions hereto and all accumulated income thereof at all other property or properties that may be acquired out of the same otherwise may thereafter be subject to the (hereinafter referred as The Trust Fund) for the charitable objects and purposes and uses hereinafter expressed with the power and on the terms and conditions here contained of and concerning the same.

- i) To create, promote educational awareness especially among the backward helpless and weaker section of the society.
- ii) To promote, manage and administer institutes of higher education such as Art and Culture, Management, Science, Engineering, and Medical Institutes and other allied Institutions as decided by the Trust Board from time to time.
- iii) To establish Institute to provide skilled, scientific technical education/ training to enable younger generation to develop self-confidence and the skills to compete and succeed in the National and International field.
- iv) To establish, manage a home or hostel for the boarding or lodging of the scholars, research students, working women, women's development, trainees , or other person or persons, irrespective of caste, creed or faith, who may be engaged in the execution of, or in furtherance of the aims and objects of the Trust.

- v) To make arrangement for lectures, seminars, discourses or study circles on Indian Culture, Philosophy, Handicrafts literature Arts and Scriptures.
- vi) To publish or cause to be published or assist in the publication books, pamphlets, magazines and writings in or about scientific, cultural, philosophical scriptures and arts.
- vii) To provide and institute awards, scholarships grants, stipends, pension to law students, young lawyers old age pension to indigent and poor lawyers funeral expenses to indigent and poor lawyers and hold moot courts, seminars legal workshops, in law colleges, universities and under Bar Council, Bar Associations.
- viii) To establish, maintain and manage cultural and artistically organizations engaged in development of art including handicraft and/or culture.
- ix) To build, maintain and manage auditoriums, gymnasiums, health centers, playing fields, stadiums and community halls for the integrated and wholesome development of the general public.

POWER OF THE SETTLER:-

The settler-cum-treasurer is the ex-officio Executive Head of the Governing Body.

The settler-cum- treasurer vest with the power to take new Trustee (s) or to expel any member (i.e. existing Trustee) if his /her activity will be against the aim and objectives of the Trust or of the growth/improvement of the Trust with the approval of Board of Trustees. The Settler of the Trust will have the power to revoke the Trust Deed and also he shall have the power to amend, alter and abridge the memorandum of the association with the approval of Board of Trustees.

The Administration , Management and control of the Trust and its properties shall vest in the hands of a committee to be called the Board of Trustee, consisting of two persons for the time being.

The Board of trustees of the trust shall comprise the Governing Body.

The Governing Body of the trust shall consist of minimum of TWO life members including the Settler.

The Governing Body may confer on the managing Trustee power to do all or any of the matter that is to say, to present for registration, admit it the execution of and take back from any registration office in India, any documents of whatsoever nature, which shall have been executed by the Trust.

6. POWER AND FUNCTION OF GOVERNING BODY :

In pursuance and fulfillment of the objects of the trust the trustees may take all necessary steps and indulge in all such activities as are likely to promote the said objects directly or indirectly and to this and shall have all necessary powers including the following.

- (a) The trustees shall be entitled to receive upon such terms as may think fit, subscriptions, donations in case or kind and or grants other funds devices from the Central and State Governments and bequest from any person, institution, trust or corporate body and to collect funds by public or private appeals for carrying out the objects of the Trust.

- (b) To manage the Trust properties and do all acts necessary for the preservations, maintenance, and management of the Trust and/or the Trust property.
- (c) The trustees will be at liberty to invest and keep invested the moneys, incomes and accretions of the income thereof in such investments as the Trustees in their absolute discretion shall think fit and proper.
- (d) To acquire by purchase, gifts, lease, exchange, hire or otherwise with or without consideration, properties, movable or immovable for any or more of the objects of the Trust.
- (e) To manage, lease, mortgage, sell dispose off or otherwise deal with all or any part of the properties of the Trust, provided always that the mortgage lease or any such assets or property of the Trust shall be in accordance with the rules and regulations and shall be for achieving the objects of the Trust.
- (f) To purchase and otherwise acquire land by way of gift or otherwise and to build and maintain houses and homes and alter and improve the same and to provide all such houses and building with light, water drainage and other necessary.
- (g) To borrow, with or without security or raise money in such manner and on such terms as may be necessary and good for achieving the objects of the Trust subject to previous approval of the Trustee.
- (h) The Trustees shall cause and accurate accounts kept of all money received and spent and of all matters and things in respect there of in course of management of Trust property or relating to the carrying out of the objects and purposes of the trust as well of the assets, credits and effects of the Trust property.
- (i) It shall be lawful for the said Trustees to file, withdraw, compromise or compound any action suit or proceedings, difference or demand relating to the Trust and / or Trust Fund or its assets upon such terms as they shall think proper and or to refer any such difference or demand to arbitration and /or to execute instruments and all things necessary or expedient for such proposes or any of them
- (j) To delegate his or their powers or duties under the trust to co-trustees or any other person if found necessary in the course of the carrying out or performing of his or their duties.
- (k) To open and operate any account or accounts whether fixed or current or savings in the name of the Trust with any Scheduled Bank or banks and /or to

close all or any such accounts or any of them as the Trustees may deem fit and proper.

(l) The trustees shall be entitled in their discretion from time to time to start, discontinue, abolish and restart any aid, charity or charitable institution, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust property or income from any particular object or objects.

(m) To amalgamate this Trust and the property with any other Trust or institution having objects incidental or similar to those of this trust, provided always that any such amalgamation is to be effected only in the event of absolute necessity and subject to the consent of two-thirds of the trustees for the time being and upon their certifying that such amalgamation was for the efficient functioning and in furtherance of the objects of this Trust and that the terms and conditions are not inconsistent with the terms hereof or the objects of the Trust set out in this Trust Deed.

(n) To appoint clerk, manager or other employees for the management of the Trust property and /or to look after the affairs thereof and to delegate to them such duties or powers as the trustees may think necessary.

(o) To nominate and appoint constituted attorneys or agents, to delegate any of the duties and powers to such constituted attorneys or agents with regards to the management of the Trust property and all matters and affairs relating to the purposes of the Trust and for collection and realization of the rents and profits and issue receipts of moneys, donations and fits without being responsible for the default of any such attorney or agent.

(p) To delegate any or more of its powers to persons, committees, bodies, as may be deemed necessary for achieving the objects of the Trust and to make rules and regulations for regulating such committees bodies and persons.

(q) To do all such other deeds, acts and things as are or may be deemed incidental or conducive to the attainment of any or more of the objects or purposes of the Trust and exercise of any of the said powers provided that in case the trustees shall take or hold any property which may be subject to any bequest, the Trustees shall only deal with or invest the same in such manner as allowed by law or by any court of law having regard to such bequests.

(r) To alter, modify and or frame, schemes and rules and regulation for carrying out of the management and running of any institution or establishment run by the trustees and for managing the affairs of the trust and otherwise for giving effects to the object and purposes of the trust and vary the

7. The trustees are chargeable only for such money, stock shares, funds and asset as shall actually come into their hands.

8. The Trustee shall be entitled to authorized by resolution any one or more of the Trustees or any other person or persons jointly or severally to receive money payable to the Trust and to pass receipts for the same and such receipts shall discharge the person or persons making the payments without they being bound to see to the application thereof and without they being liable or answerable for loss or misapplication thereof.

9. The Trustees shall not be entitled to receive any remuneration as trustees but they may reimburse themselves of all expenses actually incurred by them in connection with the Trust at their duties relating thereto.

10. The following will constitute the first Board of Trustees:

(c) With express consent of settler the Board of Trustees may add new Trustees from different walks of life to achieve any of its objects.

(d) The settlers will be for the life time and could not be removed from office and after his death his wife and in the event of death of both his successor shall be the life time Trustee and shall continue accordingly.

11. (i) The power of appointing new trustees of these presents shall be exercised by the two-third majority of the Trustees present in the meeting.

(ii) The number of trustees shall not be less than tree and not more than twenty. In case the number of trustees falls below the required minimum number, the Board of Trustees will first fill up the vacancy of the Board as envisaged in sub- clause one of this clause.

(iii) It shall be lawful for life time of the Trustees to nominate any person or persons as special invites, though there may not be any vacancy in the office of the trustees.

12 The Board of Trustees can remove any trustees, except Life Time Trustees in its duly called and held meeting by a vote of two-third majority of the total number of trustees for the time being of these presents.

13. Save as provide in Clause Ten, of these presents, if and so often as any trusted or trustees shall die, or desire to retire from or refuse to become or incapable or unfit to act, it shall be lawful for the continuing or surviving. Trustee or Trustees for the time being of these presents to appoint a trustee or trustees in the place of the trustee or trustees so dying, retiring, refusing or unfit to act as aforesaid.

14 A trustees may retire from office by giving two months notice to the other trustees of his intention to do so and such resignation shall take effect upon expiration of such notice or its earlier acceptance.

15. A Trustee shall be deemed to be incapable or to act as trustee if :

(i) He has found to be of unsound mind by a court of competent jurisdiction and the finding is in force, or.

Issue of any cheque to third party will be valid with concurrence of **Settler-cum-Treasurer** will sign ONLY in cheque.

20. **ADVISORY COMMITTEE :**

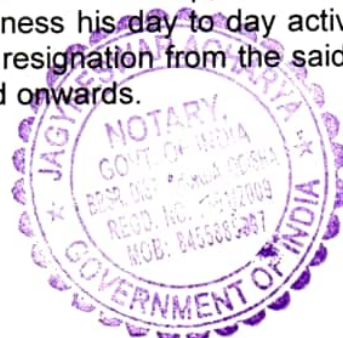

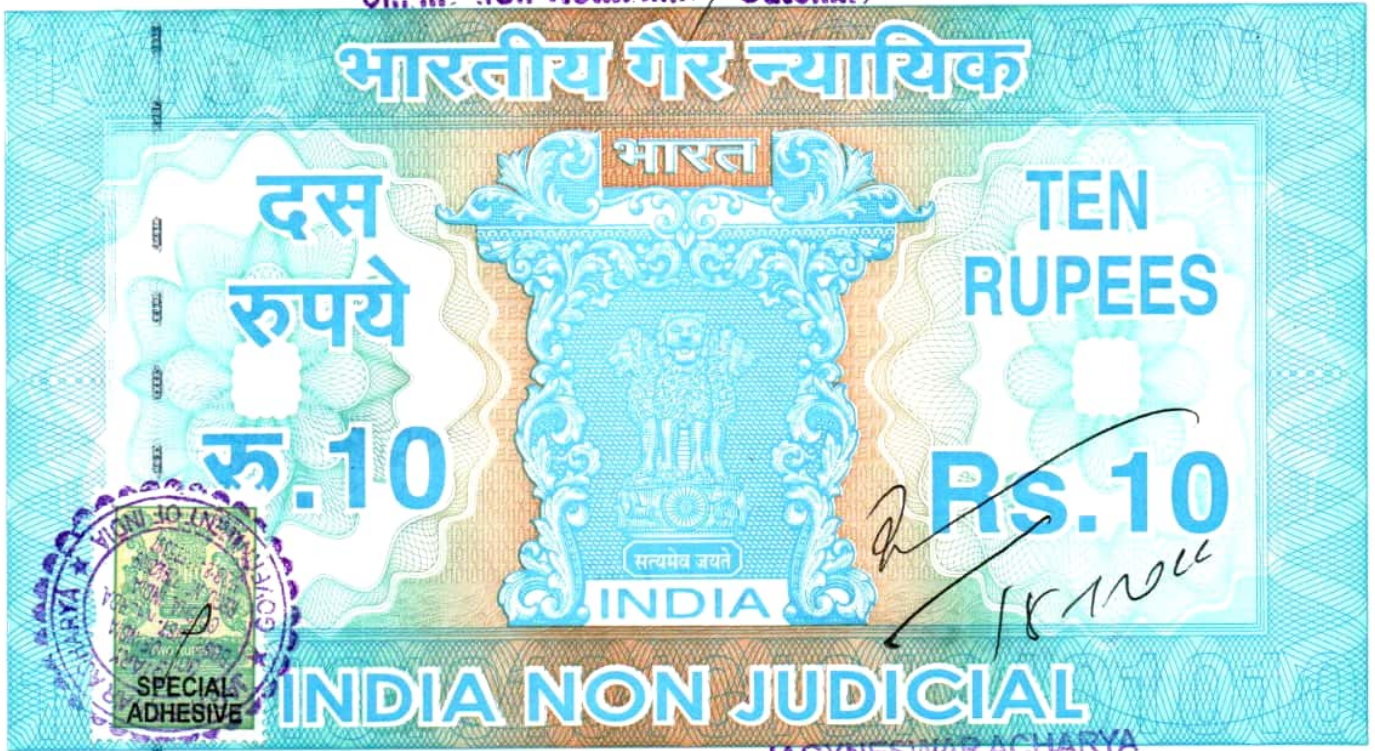

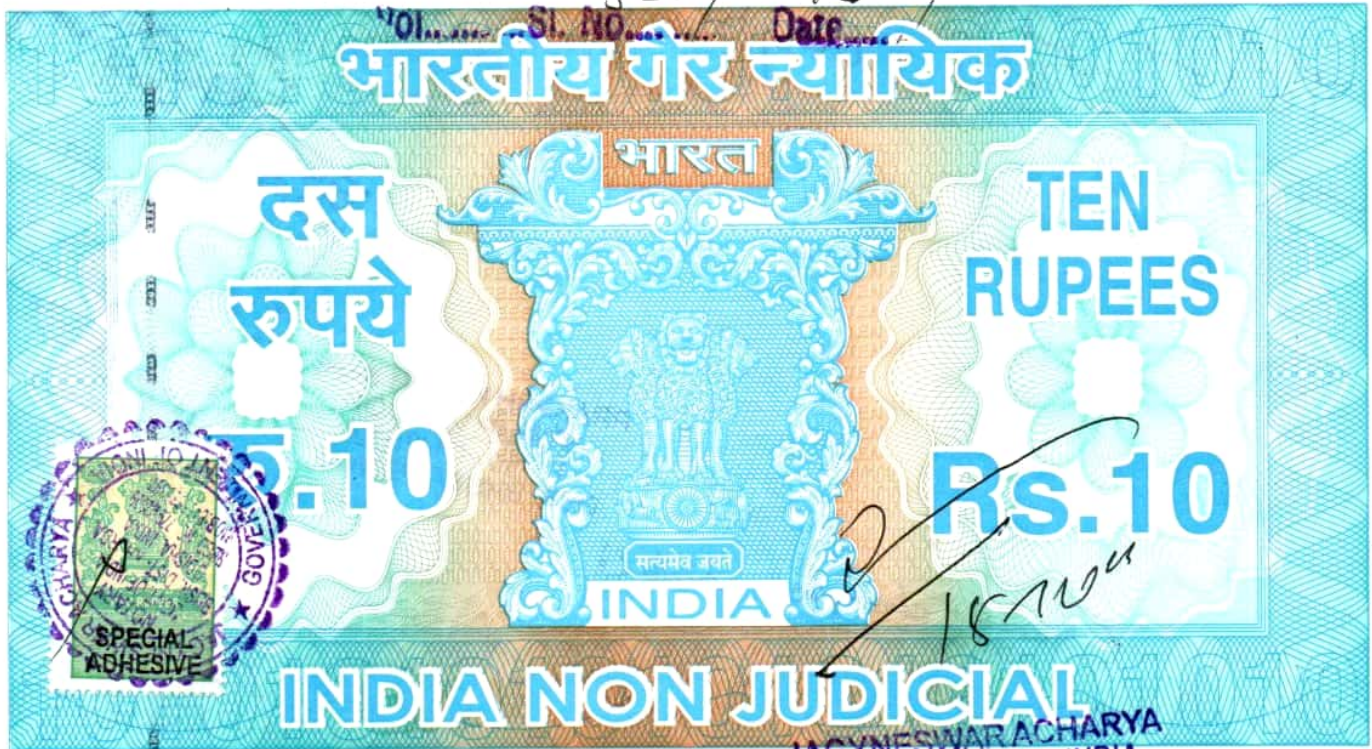
